



I, **Patricia Cooksey**, Owner of Cooksey Riding Stables, INC, agree to provide the use of, 6711 Mt. Washington Rd., Louisville, KY, to the Dalmatian Club of America. The facility will be leased from 4pm Wednesday April 25<sup>th</sup> until 6pm on Friday April 27<sup>th</sup> 2007. The facility will be available for the Show Chairman only on Tues April 24<sup>th</sup> after 4 pm. The agreed amount will be \$500/day for the facilities. The agreed amount of days to rent the facilities will be two days, payable two weeks before April 27, 2007 to Cooksey Riding Stables. This will include restroom facilities, areas for parking for exhibitors and spectators. The facility will be used during setup and actual running of the Dalmatian Club of America National Road Trial over the period as listed above. The Road Trial course will be laid out on April 25 or 26, 2007. The course will be on and through the Louisville Metro Parks that have existing trails. It will be the responsibility of Cooksey Riding Stables to notify the Metro Parks System of the use of the trails for this event. Stabling and rental of horses will be made available. An estimate of 3-5 rental horses will be needed and 8-10 personal horses will need boarding

**Rental fee-** The *Coaching Certificate (obedience only)* rental horse will be \$20/hr “try out” the evening before and \$50/event. The *12.5 mile event* will have a \$20/hour “try out” rental the evening before \$150/eventt. One exhibitor will be permitted to rent two horses to complete the *25 mile event* of the endurance. Rental of these horses will be \$20/hr “try out” fee/horse and \$150/event/horse. The 25 mile event exhibitor will be required to pay a \$50 check nonrefundable deposit. A non refundable \$25 deposit payable by a check only will be required for all other rental horses. All rental check deposits are due before 12 noon on April 11, 2007. The deposit will be applied to the total cost of the rental horse. The stables request payment not to be made by any other means other than by check. All calls to stables before April 11, 2007 12 noon deadline will be directed to the Road Trial Show Chairman. Cooksey Riding Stables will not accept any deposits that are not paid by check and also will not accept any deposits after the 12 noon April 11, 2007 deadline. Any insufficient funds check will be handled as a missed deadline and stables owner will notify the show chairman of returned check. Each exhibitor will submit a boarding/rental form with check deposit. Rental horses will be available to competitors on April 26th by 12 noon. Each rental horse will be contracted with Cooksey Riding Stables on an individual bases.

**Personal Horses-** The Road Trial Show Chairman will be responsible for the assignment of stalls for personal horses with the stable owner’s assistance. Personal horses may arrive after 4pm on April 25, 2007. Each exhibitor will complete a rental/boarding form and mail to the stable owner before the deadline (12 noon April 11,2007) to secure the stall space. All personal horses will have a current coggins less than 6 months old on the day of arrival and a health certificate not more than 20 days old on day of arrival.

**Liability Insurance-** The Dalmatian Club of America will provide proof of insurance to Cooksey Riding Stables 30 days prior to event.
